ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: August 23, 2022

Effective Date: September 7, 2022

On June 1, 2022, Timber Creek Sewer Company (Timber Creek) filed an application and motion for waiver requesting the Commission to grant a Certificate of Convenience and Necessity (CCN) for the operation of a sewer system in Clay County, Missouri as an expansion of its existing certificated service areas.

On July 27, the Commission issued its order granting Timber Creek's CCN, and ordering Timber Creek to file compliance tariffs. On August 8, Timber Creek filed the ordered compliance tariffs bearing an effective date of September 7. On August 12, the Commission ordered its Staff to file a recommendation regarding those compliance tariff filings by August 22, and ordered any other party wishing to file a recommendation to do so by that date. Timber Creek filed substitute tariff sheets on August 18, and Staff filed a recommendation advising the Commission to approve Timber Creek's compliance tariffs on August 22. No other party filed a recommendation.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes the submitted compliance tariff sheets are consistent with the Commission's July 27 order and should be approved. The

Commission also finds it reasonable to make this order effective in less than thirty days so that the effective date of the order will match the effective dates of the tariff sheets.

THE COMMISSION ORDERS THAT:

1. The tariff revisions submitted by Timber Creek on August 8, 2022 (Tracking No. YS-2023-0034) are approved, as substituted, to be effective on September 7, 2022.
