ORDER DIRECTING A STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On December 15, 2021, the Commission issued its order granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) water and sewer certificates of convenience and necessity. On December 31, 2021, Confluence Rivers filed proposed tariff sheets to incorporate the previously unregulated Shelton Estates Sewer Company and Prairie Heights, LLC sewer systems into Confluence Rivers' existing tariff. The proposed tariff sheets bear an effective date of January 30, 2022. The Commission will direct its Staff to file a recommendation about the proposed tariff sheets. The Commission will also establish a deadline for any other responses to the proposed tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the proposed tariff sheets no later than January 14, 2022.
2. Any other responses to Confluence Rivers' proposed tariff sheets shall be filed no later than January 14, 2022.
3. This order is effective when issued.
