Southwestern Bell Telephone, L.P. filed adoption notices and revised title sheets, along with evidence of registration of its fictitious name registration, d/b/a Southwestern Bell Telephone Company, in In the Matter of the Application of Southwestern Bell Telephone Company to Transfer Property and Ownership of Stock Pursuant to Section 392.300, RSMo., Case No. TO-2002-185, when it converted Southwestern Bell Telephone Company from a Missouri corporation to a Texas limited partnership, Southwestern Bell Telephone, L.P. In its Order Approving Tariffs, dated January 9, 2002, the Missouri Public Service Commission approved Southwestern Bell Telephone, L.P., d/b/a Southwestern Bell Telephone Company's tariff revisions.

Southwestern Bell Telephone, L.P., recently filed a Registration of Fictitious Name Registration with the Missouri Secretary of State, registering the fictitious name SBC Missouri, the name under which Southwestern Bell Telephone, L.P. will operate in Missouri.
