MOTION FOR LEAVE TO AMEND APPLICATION

Comes now Aquila, Inc., d/b/a Aquila Networks - MPS (“Aquila” or “Company”), in accordance with the Missouri Public Service Commission’s (“Commission”) Rule 4 CSR 240-2.080(20), and, as its Motion for Leave to Amend Application, states to the Commission as follows:

1. On April 13, 2004, Aquila filed an Application for Waiver and Motion for Expedited Treatment (the “Application”). The Application sought the Commission’s approval of a waiver of certain provisions of Aquila’s tariff in order to allow Aquila to make lump sum refunds to its customers of recently received pipeline refunds. A part of that Application proposed a process by which current transportation customers could participate in the refund, if such customers could show they were sales customers during the relevant refund time period (1983-1988).

2. Attachment C to the Application was a listing of customers that Aquila believed began service as Aquila customers after the relevant period. Volumes associated with these customers were excluded from the refund calculations contained in the Application.

3. As was pointed out in the pleading filed on April 26, 2004, by the Sedalia Industrial Energy Users’ Association (“SIEUA”), one of the customers listed on Attachment C was in fact an Aquila customer during the 1983-1988 time frame. Accordingly, Aquila seeks the Commission’s leave to amend the Application to correct this error. Such amendment requires a recalculation of the refund amount applicable to the “Lg/Industrial/Trans” class as to the Southern Star Docket RP-98-52

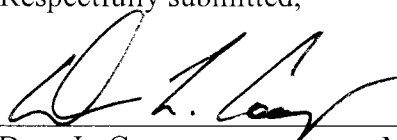
refund only. No changes are required to the PEPL Docket KP-98-40 refund calculations, nor to the refunds applicable to the other Southern Star classifications.

4. Aquila seeks to amend its Application by providing the Amended Attachment B and Attachment C that are included herewith.

5. Additionally, Aquila's seeks to amend its Application to reflect in the paragraph 8 table concerning the MPS Southern System that "LV & Transportation" "3/03-2/04 Class Usage (Mcf)" is "2,096,936" (rather than 2,061,665). Also, in the paragraph 8 table concerning the MPS Southern System and in paragraph 10A the refund amount per Mcf for the Southern System large volume or large volume transport customers should be "\$0.20898" (rather than \$0.21255). Both of these amendments are reflected in the Amended Attachment B provided herewith.

WHEREFORE, for all the foregoing reasons, Aquila respectfully requests the Commission grant Aquila's Motion for Leave to Amend Application and consider Aquila's Application to be amended as described herein.

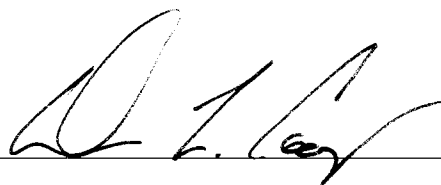
