NOTICE OF HEARING AND ORDER SETTING PROCEDURAL SCHEDULE

The Missouri Public Service Commission is giving notice of an evidentiary hearing and setting the procedural schedule as follows:

Union Electric Company d/b/a Ameren Missouri ("Ameren") shall file a post-hearing brief.

Any other party may file a post-hearing brief.

In this action, Craig Mershon objects to the use of disconnection notices, which is the same issue as Mr. Mershon raised in File No. EC-2012-0365 ("earlier case"). In the earlier case, Mr. Mershon filed the complaint on May 7, 2012, and his last activity occurred 164

days before the effective date of the Commission's dismissal: May 17, 2013.⁴ On June 13, 2013, Mr. Mershon initiated this action.⁵ By order issued on November 14, 2013, ⁶ the Commission expressly permitted Mr. Mershon to file any document by email directly transmitted to the regulatory law judge assigned to this action.

On November 13, 2013, the Commission directed each party to file a proposed procedural schedule and set a deadline.⁷ On November 14, 2013, Ameren filed its response. On November 15, 2013, the Commission's staff ("Staff") filed its response. Mr. Mershon did not file a response by the deadline of November 22, 2013.

Ameren's proposal sets forth ample time to prepare for hearing on this matter, while adhering to the Commission's regulations, which direct this action "[t]o be processed in the timeliest manner possible[.]" Staff supports that schedule by detailing the dates on which its personnel are available or unavailable. Mr. Mershon has yet to propose any schedule, in this action or the earlier case.

Therefore, the Commission will order the following.

THE COMMISSION ORDERS THAT:

- 1. The procedural schedule is ordered set forth in the body of this order.
- 2. The Commission will convene an evidentiary hearing on the merits of the complaint on December 16, 2013, at 9:00 a.m. in the City Hall Courtroom at 9641
