Western Wireless is committed to utilizing all universal support it receives in the State of Missouri for the provision, maintenance, and upgrading of facilities and services for which the support is intended as required by federal law. Western Wireless has not finalized its plans or budget for any future enhancement or expansion of network infrastructure in Missouri and is unlikely to do so without the assurance that it will receive universal support to assist with such capital expenditures. As the FCC has acknowledged, such hypothetical planning would be an inappropriate use of Company resources. Nevertheless, Western Wireless is currently evaluating the construction of two new cell sites within Missouri RSA 9 subject to its designation as an ETC. The projected cost of these cell sites is \$300,000 each, including typical site acquisition and construction costs. In addition, Western Wireless is currently evaluating faster data technologies and is likely to upgrade its GSM/GPRS network to EDGE technology in 2005.
