

DATE: January 12, 2000

On December 20, 1999, The Empire District Electric Company filed with the Commission tariff sheets with a proposed effective date of January 21, 2000 to reflect the changes to its Missouri service area as a result of its certificate of public convenience and necessity granted by the Commission in its REPORT AND ORDER (Order) issued December 7, 1999, effective December 17, 1999. On January 12, 2000, The Empire District Electric Company filed three (3) substitute tariff sheets to correct typographical errors as requested by the Missouri Public Service Commission Electric Department Staff.

In its Order the Commission approved The Empire District Electric Company's Application, as modified by the Non-unanimous Stipulation and Agreement filed on June 25, 1999, and granted The Empire District Electric Company a certificate of public convenience and necessity for the provision of electric service in the areas of Greene County, Missouri, as described in Appendix A to the non-unanimous stipulation filed on June 25, 1999.

The Missouri Public Service Commission Electric Department Staff has reviewed the filed tariff sheets and is of the opinion that they were timely filed and accurately reflect the ordered changes to The Empire District Electric Company's Missouri service area. Staff therefore recommends that the Commission issue an order approving the following proposed tariff sheets, as filed on December 20, 1999, and substituted on January 12, 2000, to become effective on January 21, 2000:
