STAFF RECOMMENDATION


COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

Subject: Staff Recommendation to Recognize a Corporate Name Change

Date: December 13, 1999

On December 1, 1999, TransWorld Network Corp. ("TWN"), a competitive telecommunications company, submitted a tariff which incorporates TWN's name change from London Telecom Network Corp. ("LTN") to TransWorld Network Corp. All pages of the original tariff remain the same, except for the name change.

TWN was certificated by the Missouri Public Service Commission to provide interexchange telecommunications service on July 26, 1993 in Case No. TA-93-299. (This is TWN's second name change. It was originally certificated as Strategic Alliances, Inc. in the above referenced case.) The tariff filing also included a copy of TWN's Amended Certificate of Authority from the Missouri Secretary of State.

The Telecommunications Department Staff (Staff) has no objections to the name change and recommends the Commission amend LTN's certificate of service authority to reflect the new company name and approve the following tariff sheets to become effective January 2, 2000:
