SUPPLEMENT TO APPLICATION

Comes now Applicant Global Connection Inc. of America d/b/a Stand Up Wireless (“Applicant”), by its undersigned counsel, and, pursuant to 4 CSR 240-2.080(20), to supplement its Application for Commission designation as an Eligible Telecommunications Carrier (“ETC”), states the following:

1. On March 23, 2011, Applicant filed its Application for Designation As An Eligible Telecommunications Carrier On A Wireless Basis. Attached as Exhibit D to that Application is a sample Lifeline Application form.

2. On September 20, 2011, after consulting with Staff of the Missouri Public Service Commission, Applicant filed as Exhibit A to its Supplement to Application a revised “Application for Low Income or Disabled Discounts.”

3. In consultation with Staff, Applicant has learned that Staff would like it to further revise its “Application for Low Income or Disabled Discounts” to remove the reference in the title to disabled discounts. Applicant hereby files a further revised Lifeline application form that reflects Staff’s request. See attached Exhibit A, “Missouri Application for Low Income Discounts,” incorporated herein by reference.

Wherefore, the Applicant requests that the Commission consider this Supplement in its determination to grant ETC status to the Applicant.
