Enclosed for filing with the Missouri Public Service Commission ("Commission") on behalf of Missouri Gas Energy ("MGE" or "Company"), a division of Southern Union Company ("Southern Union"), please find in electronic format revised tariff sheets. These tariff sheets are being filed to comply with the Commission's Report and Order in Case No. GR-2004-0209. These tariff sheets were not included in the original compliance tariff sheet filing made by MGE on or about September 24, 2004. MGE is filing these tariff sheets at the request of the Commission Staff. Accordingly, MGE requests an October 2, 2004 effective date for the same reasons as indicated in our earlier filing.


