STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

1. On May 29, 2007 ALLTEL Communications, Inc. filed an application seeking cancellation of its certificate of service authority to provide basic local telecommunications services that the Commission granted in Case No. TA-99-298, as well as its tariffs.

2. Because ALLTEL Communications, Inc. has requested cancellation of its certificate and it is not providing telecommunications service in Missouri, the Staff recommends that the Commission issue an order canceling the company's certificate of service authority. See Appendix A.

3. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2006), which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission cancel the Certificate of Service Authority it has granted to ALLTEL Communications, Inc. as well as its accompanying tariffs, MO P.S.C. Tariff No. 2 and MO P.S.C. Tariff No. 3. .

Subject: Staff Recommendation to Cancel Certificate of Service Authority and Accompanying Tariffs

Date: May 31, 2007

On May 29, 2007, ALLTEL Communications, Inc. (ACI), a competitive telecommunications company, filed its Application to Cancel Certificate of Service Authority and Accompanying Tariff. ACI was granted certificate of service authority to provide basic local telecommunications services on September 14, 1999, in Case No. TA-99-298. The Commission approved ACI's proposed tariffs, MO P.S.C. Tariff No. 2-Local Exchange Service Tariff and MO P.S.C. Tariff No. 3-Intrastate Access Service Tariff, in the same case effective August 14, 2000.

According to ACI's application, it has no business, activity or customers in Missouri under this certificate of authority. Because no customers are affected by ACI's application, the cancellation of its certificate is not detrimental to the public interest. The Staff has no objections to the request for cancellation and recommends that the Commission issue an order to cancel ALLTEL Communications, Inc.'s certificate of service authority to provide basic local telecommunications services and the accompanying tariffs, MO P.S.C. Tariff No. 2 and MO P.S.C. Tariff No. 3. The Staff is unaware of any other filing which affects or which would be affected by this proposal.
