ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: December 21, 2021

Effective Date: January 20, 2022

On November 24, 2021, WindstreamNTI, LLC (NTI), filed a letter requesting its certificate of service authority be cancelled. NTI stated that it had no Missouri customers and no tariffs on file with the Commission and requests to voluntarily cancel its certificate to provide interexchange service in Missouri. The Commission previously granted a certificate to provide interexchange telecommunications service authority to Wright Business, Inc. d/b/a Long Distance Management on December 16, 1997, in Case No. TA-98-166. The Company changed its name, effective August 16, 1999, from Wright Business, Inc. d/b/a Long Distance Management to Community Telephone Corporation, in Case No. TO-99-360. The Company again changed its name, effective April 30, 2003, from Community Telephone Corporation to Cinergy Communications Company, in Case No. XN-2003-0448. The Company again changed its name, effective September 12, 2007, from Cinergy Communications Company to Norlight, Inc., in Case No. TN-2008-0048. The Company again changed its name effective July 19, 2011, from Norlight Telecommunications, Inc. to Windstream NTI, Inc., in Case No. XN-2011-0402. The Company changed its name again, effective December 1, 2015, from Windstream NTI, Inc., to Windstream NTI, LLC, in Case No. XN-2016-0117.

On November 29, 2021, the Commission ordered its Staff to respond to NTI's application, and on December 10, 2021, Staff filed its motion to cancel NTI's certificate of

service authority, indicating that NTI's request was in compliance with 20 CSR 4240-28.011(3) regarding voluntary cancellation of certificates of service. Staff recommended that NTI's certificate be canceled. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Based on the company's request, and Staff's recommendation, the Commission finds that the certificate of service authority granted to NTI shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Windstream NTI, LLC, is cancelled.
2. This order shall become effective on January 20, 2022.
3. This case may be closed on January 21, 2022.
