**JOINT MOTION OF ALL PARTIES
TO SUSPEND PROCEDURAL SCHEDULE**

Comes now the Staff of the Missouri Public Service Commission, on behalf of all of the parties in this case, and submits this Joint Motion to Suspend Procedural Schedule. The parties request that the procedural schedule that was ordered in the August 4, 2005 Order Opening Case be suspended in accordance with this Joint Motion. In support hereof, the parties state as follows:

1. By its order of July 28, 2005, in Case No. TX-2003-0301, the Commission granted Southwestern Bell Telephone, L.P., d/b/a SBC Missouri a temporary waiver of the requirement of Rule 4 CSR 240-29.040(4) that the originating Calling Party Number be included in the 11-01-XX billing records for wireless-originated calls, until September 30, 2005. The temporary waiver was intended to allow the Commission to investigate this matter further.

2. The August 4, 2005 order opening this case established a procedural schedule to address this matter by contested case procedures to be concluded by September 30, 2005.

3. The parties have conferred. They would like to have the opportunity to meet and attempt to resolve this issue in a more informal setting. The parties agree that the temporary waiver can and should be extended in order to do so. The parties agree to meet and confer regarding the waiver period necessary for compliance with this rule. The parties agree to attempt

to resolve this matter by unanimous stipulation. If the parties do not reach agreement and file a unanimous stipulation by November 18, 2005, they agree to jointly or separately file proposed procedural schedules for the resumption of the contested case proceedings by no later than November 18, 2005. The parties understand that in this event the waiver will have to again be extended to include the time necessary to submit the case within the time frame of the procedural schedule that is ordered.

4. The parties request that the temporary waiver be extended until November 30, 2005. The parties request that they be directed, to file, by no later than November 18, 2005, either a unanimous stipulation with respect to the waiver and waiver period, or, if a unanimous stipulation cannot be reached, proposed procedural schedules to be used to resolve the matter.

5. SBC Missouri, the Office of the Public Counsel, the Small Telephone Company Group, and the Missouri Independent Telephone Group have all authorized Staff to submit this Joint Motion on their behalf.

WHEREFORE, the parties to this case jointly move the Commission for its order suspending the procedural schedule in this case.
