STAFF'S STATUS REPORT ON STATE NUMBER POOLING TRIALS

COMES NOW the Staff of the Missouri Public Service Commission and for its report states:

- 1. On September 25, 2001, the Commission issued an Order Directing State Number Pooling Trials which ordered state number pooling trials in the 314 and 816 NPAs with implementation dates of January 2, 2002, and February 1, 2002, respectively, and which directed the Staff to file periodic reports advising the Commission of the status of the 1,000s block number pooling trials.
- 2. On October 25, 2001, the Commission issued an Order Regarding Implementation Dates For State Number Pooling Trials which revised the implementation dates for the state number pooling trials in the 314 and 816 NPAs to January 22, 2002, and February 22, 2002 respectively.
- 3. The Staff was informed that the state number pooling trials were successfully implemented in the 314 and 816 NPAs on the mandated start dates.
