STATUS REPORT

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its *Status Report and Recommendation to Suspend Proceeding*, states as follows:

- 1. On October 21, 2011, Mr. Travis Miller ("Mr. Miller" or "Applicant") filed with the Commission an *Application* seeking approval to change the electric supplier to his property from Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") to Ozark Border Electric Cooperative ("Ozark Border").
- 2. On December 27, 2011, counsel for Ozark Border informed the undersigned Staff Counsel that Mr. Miller and Ozark Border had resolved the issues underlying this case. Staff counsel contacted Mr. Miller who confirmed he and Ozark Border had reached an agreement, and that he would withdraw his application when that agreement has been carried out.
- 3. On January 17, 2012, Staff filed its *Status Report and Recommendation to Suspend Proceeding*, in which it suggested suspending this proceeding because the parties had reached an agreement, and that Mr. Miller would withdraw his application once terms of the agreement had been carried out.

- 4. On January 18, 2012, the Commission suspended this proceeding, and ordered Staff to file a status report no later than February 1, 2012.
 - 5. This filing is intended to comply with that *Order*.
- 6. Staff understands that the agreement between the parties has not yet been fully carried out. Staff requests leave to file a further status report regarding this matter not later than March 1, 2012, unless the applicant files a notice of dismissal before that date.

WHEREFORE, Staff submits this *Status Report* for the Commission's information and consideration.
