**STAFF RECOMMENDATION REGARDING TARIFF FILING**

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its Staff Recommendation Regarding Tariff Filing states the following:

1. On October 23, 2008, the Missouri Public Service Commission (the Commission) received a Rate Increase Request Letter from Hickory Hills Water & Sewer Co., Inc. (Hickory Hills or the Company) requesting the Commission authorize a 100% increase in its annual operating revenues.

2. On July 7, 2009, Staff, Hickory Hills, and the Office of the Public Counsel (OPC) filed a Notice of Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request (Unanimous Agreement).

3. On July 8, 2009, the Commission issued its Order Approving Unanimous Agreement, approving the Unanimous Agreement and authorizing Hickory Hills to file tariffs in compliance with the terms thereof.

4. On July 9, 2009, Hickory Hills filed revised tariff sheets with an effective date of August 10, 2009. This filing was submitted in Tariff File Number YW-2009-0828.

5. Subsequently on July 9, 2009, the Commission issued its Order Directing Filing and Setting Deadlines, ordering Staff to file a recommendation as to the tariff revisions by July 17, 2009.

6. James M. Russo, Rate and Tariff Examination Supervisor, has examined Hickory Hills' revised tariff sheets, P.S.C. MO. No. 2, 4<sup>th</sup> Revised Sheet No. 4, Canceling 3<sup>rd</sup> Revised

Sheet No. 4 and P.S.C. MO. No. 2, 2<sup>nd</sup> Revised Sheet No. 5, Canceling 1<sup>st</sup> Revised Sheet No. 5, and notes that the tariff revisions reflect the agreed-upon rate increase and should be allowed to take effect no later than August 10, 2009. See *Russo Affidavit*, attached hereto.

7. The Commission has the authority to approve the subject proposed tariff revisions in accordance with Sections 393.140 (11) and 393.150 RSMo (2000).

**WHEREFORE**, Staff recommends the Commission issue an order approving the following proposed revised tariff sheets currently pending in Tariff File No. YW-2009-0828, to be effective no later than August 10, 2009:

P.S.C. MO. No. 2, 4<sup>th</sup> Revised Sheet No. 4, Canceling 3<sup>rd</sup> Revised Sheet No. 4, and  
P.S.C. MO. No. 2, 2<sup>nd</sup> Revised Sheet No. 5, Canceling 1<sup>st</sup> Revised Sheet No. 5.




