**POSITION STATEMENT OF THE OFFICE OF PUBLIC COUNSEL**

COMES NOW, the Office of Public Counsel (Public Counsel), and respectfully states its position as to the Issues presented in the above captioned matter:

I. At this time, Public Counsel takes no position on the issue of whether the City of Rolla's requests for an assignment of the exclusive territory and transfer of Intercounty Electric Cooperative Association's facilities are in the public interest. However, Public Counsel reserves the right to take a position on all issues related to the proposed reassignment of service territory between the parties at a later date.

II. At this time, Public Counsel takes no position on the issue of whether the commission should assign the annexed area, in whole or in part, to the exclusive territory of the City of Rolla. Public Counsel is aware that a number of the current Intercounty customers who reside in the annexed area are opposed to switching their service from Intercounty to the City. Public Counsel believes that the opinions voiced by the customers who will be affected by the Commission's decision in this case should be given due consideration. Public Counsel reserves the right to take a position on this issue at a later date.

III. In the event that the Commission determines that the annexed area, in whole or in part, should be assigned to the City of Rolla, Public Counsel believes that Intercounty is entitled to be paid fair and reasonable compensation for its facilities and property which serves the annexed area. Public Counsel takes no position on what this amount should be, except to request that the Commission follow the dictates of RSMo 386.800.5. Public Counsel reserves the right to take a position on issues related to compensation at a later date.

IV. At this time, Public Counsel takes no position on any other issue related to calculating fair and reasonable compensation in the event of a transfer of territory or facilities. Public Counsel reserves the right to take a position on these issues at a later date.
