3. WESCO is a subsidiary of the Williams Companies, Inc., a publicly-held company with operating subsidiaries engaged in various energy-related and telecommunications businesses. WESCO offers a full range of products and services to energy markets throughout North America. WESCO's core business includes natural gas, electricity and other commodity trading activities as well as energy-related price-risk management products and services. WESCO

also provides financial services to participants in the energy industry.

- 4. On September 2, 1997, Union Electric Company (UE) filed an application with the Commission requesting approval of an experimental retail wheeling pilot. The pilot encompasses two market structures: a Power Exchange model whereby UE will shop for the best electric generation prices available on the open market and will pass any savings to the customer, and a Direct Access model whereby customers can select an alternative energy supplier from a list of qualified providers. All major classes of UE's Missouri retail electric customers, except street lighting customers, will participate in the pilot.
- 5. WESCO is a potential participant in the experimental retail wheeling pilot and, therefore, has a direct interest in this proceeding which is not similar to the public generally and which cannot be adequately represented by any other party to this proceeding.

WHEREFORE, WESCO respectfully requests the Commission grant it leave to intervene and participate fully in these proceedings.
