Allegiance Communications, LLC holds a Video Service Authorization in the State of Missouri. On November 7, 2012 Allegiance Communications, LLC notified the Commission that it intended to cease providing service in Plattsburg, Dearborn, Camden Point, Braymer, Maysville, Gower, Seligman and Washburn, Missouri. Allegiance subsequently requested that activities to terminate the Video Permits in these political subdivisions be postponed, and the Commission granted such request to postpone termination on December 5, 2012.

On March 25, 2013, Allegiance Communications, LLC notified the Commission that it wished to keep the Video Permits for Rushville, Gower, Maysville, and Plattsburg and continue with the termination of the Video Permits for all other communities.

On April 8, 2013, the Commission ordered that the Video Service Authorization held by Allegiance Communications, LLC be amended to remove the political subdivisions of Dearborn, Camden Point, Braymer, Seligman and Washburn.

On May 6, 2013, a Notice of Discontinuance of Service was filed for all political subdivisions which Allegiance Communications, LLC had been authorized to serve. This included the political subdivisions removed in the April 8, 2013 Order, and additional political subdivisions which Allegiance has ceased serving. The files were consolidated pursuant to an Order issued May 10, 2013. An Order Directing Status Report was also issued on May 10, 2013, to which this notice is responsive.

Allegiance Communications, LLC has now ceased providing video services to all political subdivisions for which it was previously authorized including Rushville, Gower, Maysville, Plattsburg, Edgerton, Hamilton and Lathrop, Missouri.

Allegiance Communications, LLC has notified the communities of their decision to cease provision of video services and certain communities have been successful in finding an alternate provider.

Please advise if the Commission requires anything over and above this notification letter to terminate the Allegiance Communications, LLC video service authorization for all political subdivisions in the State of Missouri, including Rushville, Gower, Maysville, Plattsburg, Edgerton, Hamilton and Lathrop. Thank you.
