UNANIMOUS STIPULATION

COME NOW the parties to this case pursuant to 4 CSR 240-2.115 and present the following Unanimous Stipulation for the Commission's consideration:

1. The parties stipulate and agree that all prefiled testimony should be admitted into evidence and the record in these consolidated proceedings, as follows:

2. The record in this case shall include the exhibits identified in paragraph 1 and the transcripts of prior proceedings (including evidence admitted into the record as indicated in such transcripts) in these consolidated cases.

3. The parties further stipulate and agree that the Commission may decide the issues in this case based on the foregoing record without holding a hearing, in accordance with the following schedule (unless otherwise subsequently agreed and approved):

Initial Briefs	September 30, 2005
Reply Briefs	October 20, 2005
Proposed Orders (with findings and conclusions)	October 31, 2005

4. If the Commission approves this Unanimous Stipulation, the parties waive their respective rights to present any additional evidence, to make opening statements, to cross-examine witnesses, to the holding of a hearing and the creation and review of any transcript thereof, and to make any oral argument. The parties reserve the right to make written argument regarding the weight that should be accorded any particular piece of evidence, including but not limited to the argument that certain evidence should not be accorded any weight.

5. If the Commission does not approve this Unanimous Stipulation, it shall become null and void and none of the parties shall be bound by any of the terms hereof. Minor adjustments to the proposed final case schedule shall not constitute a rejection hereof.

6. The parties agree to cooperate with each other in the presentation of this Unanimous Stipulation to the Commission for approval, including regarding the making of any responses to Commission questions regarding this Unanimous Stipulation, and will take no action, direct or indirect, in opposition to approval of this Unanimous Stipulation.

WHEREFORE, the parties request the Commission to approve this Unanimous Stipulation and direct the parties to proceed in accordance herewith, and to grant such other and further relief as the Commission deems meet and proper in the premises.
