The Commission has approved Gabriel's application for certificates of service authority to provide basic local, local exchange, and interexchange telecommunications services in Missouri and to classify the company and its services as competitive.

3. On or about December 17, 1999, the North American Numbering Plan Administrator Neustar, Inc. filed a Petition proposing approval of an NPA Relief Plan for the 314 and 816 Area Codes. On January 19, 2000 the Commission issued its order setting an intervention date of February 4, 2000.


4. Gabriel seeks to intervene in this proceeding because the Commission's decision may adversely affect Gabriel's interests as a provider of telecommunications services, including as a CLEC. Gabriel neither supports nor opposes the application at this time, as it has not obtained sufficient information.

5. Gabriel's interests as a telecommunications company are different from those of the general public. Furthermore, Gabriel's intervention in this proceeding is in the public interest because of Gabriel's interests in enhancing competition and because of its expertise in the telecommunications industry.


WHEREFORE, Gabriel Communications of Missouri, Inc., respectfully requests the Commission to issue its order granting its Application to Intervene.


