3. On or about December 17, 1999, the North American Numbering Plan Administrator Neustar, Inc. filed a Petition proposing approval of an NPA Relief Plan for the 314 and 816 Area Codes. On January 19, 2000 the Commission issued its order setting an intervention date of February 4, 2000.
