#### ARTICLES OF AMENDMENT OF THE PLATTE-CLAY ELECTRIC COOPERATIVE, INC., EXECUTED PURSUANT TO CHAPTER 394 R.S.MO.

KNOW ALL MEN BY THESE PRESENTS, that the Platte-Clay Electric Cooperative, Inc., for the purpose of amending Article Seven of its Articles of Incorporation, pursuant to Section 394.090 of the Rural Electric Cooperative Law, hereby executes the following Articles of Amendment.

# I

A. The name of the cooperative is Platte-Clay Electric Cooperative, Inc.

B. The address of its principal office is Platte City, Missouri.

The date of the filing of its Articles of Incorporation in the Office of the Secretary of State is August 27, 1938.

## III S III

ArticleeVII of its Articlestof Incorporation are amended

to provide as follows:

"Seventh. The cooperative may not sell, lease or otherwise dispose of, except by mortgage, or deeds of trust, all or any substantial portion of its property unless such sale, lease, or other disposition is authorized at a duly held meeting of the members thereof by the affirmative vote of not less than two-thirds of all of the members of the cooperative and unless the notice of such proposed sale, lease or other disposition shall have been contained in the notice of the meeting.

Notwithstanding anything else herein contained, the board of directors of the cooperative, without authorization by the members thereof, shall have full power and authority to authorize the execution and delivery of a mortgage or mortgages or a deed or deeds of trust upon, or the pledging or encumbering of, any or all of the property, assets, rights, privileges, licenses, franchises and permits of the cooperative, whether acquired or to be acquired, and wherever situated, as well as the revenues and income therefrom, all upon

such terms and conditions as the board of directors shall determine, to secure any indebtedness of the cooperative to the United States of America or any instrumentality or agency thereof, or to any bank or other financial institution or organization."

FIRST: The name of the Corporation prior to its conversion into a cooperative is Platte-Clay Electric Cooperative, Inc.

SECOND: The address of the principal office of the Corporation is Platte City, Missouri.

THIRD: The articles of incorporation of the Corporation were filed in the office of the Secretary of State on August 29, 1938.

FOURTH: The Corporation was organized as a cooperative association under Mo. Rev. Stat. (1939), Sections 14405, et seq.

FIFTH: The name assumed by the Corporation is Platte-Clay Electric Cooperative, Inc.

SIXTH: The Corporation elects to become a cooperative, non-profit, membership corporation subject to the Rural Electric Cooperative Act, Mo. Rev. Stat. (1939), Sections 5386, <u>et seq</u>.

SEVENTH: The manner and basis of converting shares of stock of the Corporation into memberships in the converted corporation after completion of the conversion shall be as follows: Each stockholder of the Corporation shall automatically, upon completion of the conversion become a member in the converted corporation.

EIGHTH: The board of directors of the Corporation shall constitute the board of directors of the converted corporation and shall hold office until the next following annual meeting of the members or until their successors shall have been elected and shall have qualified.
