**ORDER NUNC PRO TUNC**

On October 22, 2014, the Commission issued an Order Approving Disposition Agreement and Tariff. That order approved a Supplement Updated Agreement between Staff and P.C.B. regarding P.C.B.'s sewer rates.

On August 9, 2016, the Staff of the Commission filed a Motion for Order Nunc Pro Tunc. Staff explains its' agreement with P.C.B. indicated that P.C.B. was delinquent on its 2012, 2013, and 2014 annual assessments. However, Staff's cover pleading inadvertently stated that P.C.B. was not delinquent on those payments. The Commission's order approving the agreement was silent as to those assessment payments. As a result, Staff filed this motion for the order nunc pro tunc to reflect the parties' agreement that the Commission order approving the agreement does not waive those delinquent assessment amounts.

Commission Rule 4 CSR 240-2.080(15) allows parties ten days to respond to motions. No party responded to the application. Therefore, the Commission will take up the motion unopposed.

The Commission finds Staff's motion reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Paragraph one of the Commission's October 22, 2014 Order Approving Disposition Agreement and Tariff is corrected *nunc pro tunc* to state that the Commission finds the Updated Agreement and Supplemental Updated Agreement and its corresponding revised tariff sheets reasonable. The Commission's approval of the Agreements and corresponding revised tariff does not waive any assessment amounts due and owing of P.C.B., Inc. to the Commission.
2. This order shall be effective when issued.


