**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND  
ESTABLISHING TIME TO RESPOND TO PROPOSED TARIFF**

On April 5, 2017, Missouri-American Water Company filed a tariff in its most recent rate case, File No. WR-2015-0301, that consolidates its various sewer tariffs into a single tariff. The consolidated tariff has resulted from a workgroup established by an order of the Commission in WR-2015-0301. The Commission's report and order in File No. WR-2015-0301 has been appealed, and is currently pending in the Missouri Court of Appeals, Western District (WD79988). To avoid creating confusion by dealing with this tariff in a case for which an appeal is pending, the Commission has moved Missouri-American's tariff into this file. All parties to Missouri-American's rate case will be made parties to this case.

Missouri-American's tariff carries a 30-day effective date of May 5, 2017. The Commission will direct its Staff to file a recommendation regarding the tariff, and will also establish a date for any other party to file a response regarding the tariff.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Staff shall file a recommendation regarding Missouri-American's tariff no later than April 14, 2017.

2. Any other party wishing to respond to Missouri-American's tariff shall do so no later than April 14, 2017.

3. The Commission's data center shall make all parties to File No. WR-2015-0301 parties to this case.

4. This order shall be effective when issued.
