

## **Tariff Change** File No. 200100016, Case No. TT-2001-11

On July 7, 2000, GTE Communications Corporation (GTE), a competitive interexchange and local exchange telecommunications company, filed proposed Interexchange Tariff No. 3 to replace Tariff No. 1. According to the cover letter, GTE made no changes to the proposed Tariff No. 3.

GTE respectfully requests expedited treatment of the Tariff No. 3 by July 27, 2000. The Telecommunications Department Staff (Staff) has no objections to the proposed tariff, as amended, and recommends the Commission issue an order to amend GTE's certificate of service authority to provide interexchange telecommunications services and approve the following Tariff No. 3 pages effective August 7, 2000 or at the Public Service Commission's (Commission) earliest convenience:

## **Name Change and Adoption Notice** File No. 200100034, Case No. TO-2001-30

On July 12, 2000, GTE filed a name change and adoption notice from GTE Communications Corporation to Verizon Select Services. Included with the tariff filing is a copy of GTE's Registration of Fictitious Name from the Missouri Secretary of State. GTE also proposes to change GTE Communications Corporation d/b/a GTE Long Distance P.S.C. No. 1 to Verizon Select Services.

On July 14, 2000, GTE filed substitute sheets. The substitute sheets were reviewed and found acceptable.

The Staff has reviewed GTE's filings and finds no objections to the tariff approval to be expedited by July 27, 2000 and the proposed name change and adoption notice approval to be expedited by July 31, 2000. Staff believes the expedited request complies with the requirements for expedited Commission consideration outlined in 4 CSR 240-2.065 (2) and 4 CSR 240-2.080 (17), and 4 CSR 240-2.060 (16) for a name change. Approving tariffs with requested effective dates comply with corresponding events at the national level involving the GTE and Bell Atlantic merger.
