STAFF TEST YEAR RECOMENDATION

Comes now the Staff of Missouri Public Service Commission (Staff) in response to the November 16, 2000 Suspension Order And Notice of the Missouri Public Service Commission (Commission) directing the Staff to file on or before December 15, 2000 a pleading either indicating concurrence in the test year recommended by The Empire District Electric Company (EDE) or proposing alternatives to EDE's recommended test year. In response thereto, the Staff states as follows:

1. On November 30, 2000, pursuant to the Commission's November 16, 2000 Suspension Order And Notice, EDE filed its Test Year Recommendation which states as follows:

As reflected in the prepared direct testimony (p. 4) of Robert B. Fancher filed on November 3, 2000, Empire recommends as the test year the twelve months ended December 31, 2000. Because of the significant plant addition of Empire's new State Line Combined Cycle Plant (SLCC), which is scheduled to be operational on June 1, 2001, the "test year as updated" should be through and including May 31, 2001, except for costs related to SLCC which would be addressed in the true-up. (See separate pleading filed regarding true-up.) Empire anticipates a postage increase in 2001, and therefore may also propose certain isolated changes such as that.

The Staff concurs in the test year recommendation of EDE of the twelve (12) months ended December 31, 2000, updated for material, known and measurable changes that maintain a



proper matching of revenues, expenses and rate base, including the State Line Combined Cycle Plant (SLCC), if it is "fully operational and used for service" (Section 393.135 RSMo 1994), which is scheduled to be operational on June 1, 2001.

Wherefore the Staff concurs in the test year recommendation of The Empire District Electric Company, filed on November 30, 2000, of the twelve (12) months ended December 31, 2000.
