STAFF'S MOTION TO COMPEL ANSWERS TO DATA REQUESTS

COMES NOW the Staff of the Missouri Public Service Commission ("the Staff") and, for its Motion to Compel Answers to Data Requests, states to the Missouri Public Service Commission ("Commission") as follows:

- 1. On October 15, 1999, Missouri-American Water Company ("MAWC" or "Company") submitted to the Commission proposed tariff sheets intended to implement a general rate increase for the water and sewer service that it provides to its customers in the Missouri service area of the company. The proposed water service tariffs were designed to produce an annual increase of approximately 53.97 percent in the Company's revenues. The proposed sewer service tariffs were designed to produce an annual increase of approximately 5.0 percent in the company's revenues.
- 2. On November 4, 1999, the Staff submitted a series of data requests ("DRs) to MAWC regarding the Company's rate increase request. These DRs requested that the Company furnish the following information to the Staff:
 - a. DR No. 3801 requested that the Company furnish balance sheets and income statements for American Water Works Company, Inc., on a stand-alone basis

- ("American"), for American Water Works Company, Inc, and its subsidiaries, on a combined basis ("Combined Companies"); and for the Company.
- b. DR No. 3802 requested that the Company provide detailed information about the short-term debt, long-term debt, and preferred stock of the Company, American, and the Combined Companies.
- c. DR No. 3803 requested that the Company provide information about the interest rates on all short-term debt of the Company, American, and the Combined Companies, and the average interest rate on short-term debt of the Company for the period ended September 30, 1999.
- d. DR No. 3804 requested that the Company provide detailed information about the items included on the September 30, 1999 balance sheets of the Company, American, and the Combined Companies as "Losses on Reacquired Debt."
- e. DR No. 3805 requested that the Company provide additional information so that the answers to DRs 3801, 3802, 3803 and 3804 could be updated to December 31, 1999.
- f. DR No. 3806 requested that the Company provide copies of the sections of the mortgage indentures of the Company and of American that describe each company's net earnings and/or interest coverage requirements.
- g. DR No. 3807 requested that the Company provide information about the return on equity expectations of the Company, American and the Combined Companies for the fiscal years of 1999, 2000, and 2001.
- h. DR No. 3808 requested that the Company provide copies of correspondence between the Company or American and outside financial analysts concerning the Company's or American's credit rating, capital structure and/or cost of capital.
- i. DR No. 3809 requested that the Company provide a copy of American's SEC Form 10-K for the fiscal year ended December 31, 1999.
- j. DR No. 3810 asked the Company to describe the nature of any changes in its capital structure that will occur between December 31, 1999 and September 8, 2000.
- 3. Copies of Staff's Data Requests Nos. 3801-3810 are attached hereto as Exhibit A.
- 4. All of the information that the Staff requested in its Data Requests Nos. 3801-3810 is relevant and material to the issues that are presented in this case.
- 5. Rule 4 CSR 240-2.090 (2) requires parties, to whom data requests are directed, to file responses to the DRs within 20 days after receipt unless otherwise agreed by the parties to the

DRs. The rule further provides that if a party objects to the data requests or is unable to answer within 20 days, the recipient will serve all of its objections or reasons for its inability to answer in writing upon the requesting party within 10 days after it receives the DRs.

- 6. The rule therefore required that the Company either answer DRs 3801-3810 by November 24, 1999, or object to them or tell why it would not be able to timely respond to them, by no later than November 14, 1999.
- 7. The parties did not agree that the answers to DRs 3801-3810 could be delayed beyond the due date specified in 4 CSR 240-2.090 (2).
- 8. The Company has neither responded to any of the said DRs 3801-3810, nor objected to them, nor informed the Staff why it is unable to answer the DRs by the deadline and when it will be able to provide the answers.
- 9. On December 27, 1999, the Commission issued its Order Adopting Procedural Schedule, in which, among other things, it ordered the Staff to file direct testimony on all issues except rate design by 3:00 p.m. on March 20, 2000.
- 10. Unless the Staff promptly receives the information that it requested in DRs 3801-3810, the Staff will not be able to adequately prepare the testimony that it must file by March 20, 2000.

WHEREFORE, the Staff moves the Commission for an order compelling the Company to answer Staff Data Requests Nos. 3801-3810 within five days after the entry of the Commission's order to compel answers.
