

ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION ORDER

J D Services, Inc. d/b/a American Freedom Network (Applicant or AFN), a Nevada corporation, submitted its Adoption Notice on August 7, 2000, designed to adopt all schedules, rules, notices, concurrences, schedule agreements, divisions, authorities or other instruments filed with the Missouri Public Service Commission prior to July 31, 2000, by J D Services, Inc., a Utah corporation (J D Services Utah). The filing also included a substitute page to correct and update a list of waivers and a revised title sheet. On August 25, 2000, the substitute page to correct and update the list of waivers was refiled and corrected at the request of the Commission's staff.

On August 29, 2000, the Commission's staff filed its recommendation to approve and accept AFN's adoption of the tariff of J D Services Utah. Staff stated that the revised tariff pages, as amended, comply the Commission's previous order issued on July 21, 2000, in Case Nos. TA-2000-68 and TM-2000-699.

AFN was certificated by the Commission to provide interexchange telecommunications services in Case No. TA-2000-698 on July 21, 2000. A merger between AFN and J D Services Utah was also



approved by the Commission in Case No. TM-2000-699 on July 21, 2000. A joint order was issued. The filing of the adoption notice and the revision of certain tariff pages comply with the requirements of the July 21, 2000, joint order.

The Commission has reviewed the Applicant's filing and the Staff recommendation and finds that the adoption notice should be recognized and that the revised tariff pages should be approved.

IT IS THEREFORE ORDERED:

- 1. That the adoption notice filed by J D Services, Inc. d/b/a

 American Freedom Network (a Nevada corporation) is recognized.
- 2. That the adoption notice denominated Missouri Public Service Commission Tariff No. 1, Original Adoption Notice and the First Revised Title Page, and the Second Revised Page 2 filed by J D Services, Inc. d/b/a American Freedom Network (a Nevada corporation), reflecting the adoption notice and revised tariff pages and assigned tariff file number 200100117, as substituted, are approved for service on and after September 5, 2000.
- 3. That this order shall become effective on September 5, 2000.

4. That this case may be closed on September 6, 2000.
