STATUS REPORT

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and reports to the Missouri Public Service Commission ("Commission") as follows:

1. The Company filed a change request on Friday, June 5, 2015, identifying certain errors that warranted correction to the impact evaluation, measurement and verification ("EM&V") reports for Ameren Missouri's 2014 energy efficiency programs. The change request was filed pursuant to the 2012 Unanimous Stipulation and Agreement approved by the Commission.

2. On June 9, 2015, the Company held a telephone conference after notifying all parties. Three parties attended the conference, including Commission Staff ("Staff"), the Office of the Public Counsel ("OPC"), and Ameren Missouri.

3. During the June 9 conference, the Company agreed to provide workpapers and support for the correction of the identified errors and to coordinate correction of errors with the evaluator. The Company further agreed to cooperate with Staff and OPC to allow review of all calculations and workpapers.

4. Staff indicated that once its review is complete, it would communicate its agreement or disagreement with the corrections. If Staff is in agreement with the corrections, corrected EM&V reports will be filed in this docket. OPC also concurred with this approach. Objections to the change request are due to be filed by June 26, 2015.

5. The parties attending the June 9 conference agreed that, at this time, there is no need to schedule further procedural steps or set a date for hearing.

6. A copy of this pleading was provided to OPC and Staff and both agree with the contents herein.

WHEREFORE, Ameren Missouri respectfully requests that the Commission accept this Status Report, incorporate the recommendations made herein, and grant any other and further relief as it deems just and equitable.
