**STATUS REPORT**

**COMES NOW** Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers” or “Company”) and for its *Status Report* respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1.       On December 15, 2021, the Commission issued its *Order Granting Certificate of Convenience and Necessity* (“Order”) in this case and the accompanying Case No. WA-2021-0425. The Order granted Certificates of Convenience and Necessity for the various water and sewer assets of The Missing Well, Spring Branch, Shelton Estates, Clemstone, Prairie Heights, and Cedar Green Land Acquisitions, LLC, and requires Confluence Rivers to notify the Commission of closing on any of the assets in these cases.

2.       On January 4<sup>th</sup>, 2022, Confluence Rivers filed its *Notice of Closing as to Spring Branch* with the Commission in Case No. WA-2021-0425.

3.       On February 16<sup>th</sup>, 2022, Confluence Rivers filed its *Notice of Closing as to Clemstone and The Missing Well* with the Commission in Case Nos. WA-2021-0425 and SA-2021-0426.

4.       On March 14<sup>th</sup>, 2022, Confluence Rivers filed its *Notice of Closing as to Prairie Heights* with the Commission in Case No. SA-2021-0426.

5. On March 31<sup>st</sup>, 2022, Confluence Rivers filed its *Notice of Closing as to Cedar Green Land Acquisition, LLC* with the Commission in Case Nos. WA-2021-0425 and SA-2021-0426.

6. The only assets in these cases that have not yet been closed on by Confluence Rivers are the sewer assets of Shelton Estates.

7. Confluence Rivers still intends to close on these assets, however, there continues to be discrepancies and encumbrances regarding the assets of Shelton Estates that are delaying closing.

8. Confluence Rivers intends to close on the assets of Shelton Estates as soon as the discrepancies and encumbrances are resolved. Confluence Rivers anticipates closing occurring within this third quarter of 2022.

9. Confluence Rivers will provide notice of closing on the assets to the Commission as soon as the assets of Shelton Estates are closed upon.

**WHEREFORE**, Confluence Rivers respectfully submits this *Status Report* to the Commission.
