
RE: Requests for Increases in Annual Water and Sewer System Operating Revenues MO PSC Small Utility Rate Case Procedure


Dear Secretary,

S. K. & M. Water and Sewer Company (the Company) holds a certificate of public convenience and necessity granted by the Missouri Public Service Commission (the Commission), under which the Company provides sewer collection and treatment services in Perry County, Missouri. The Commission first authorized the Company to provide regulated water and sewer utility services in 1973. The Company currently provides service to approximately 295 water customers and 170 sewer customers within its certified area under the provision of its Commission-approved tariffs. The Company's customer rates for water service and sewer service became effective July 5, 2019.

Pursuant to 4 CSR 240-10.075, the Commission's Staff Assisted Rate Case Procedure, the Company is hereby requesting an increase of \$4,000.00 in its annual water system operating revenues, and an increase of \$8,000.00 in its annual sewer system operating revenues. The Company understands that the design of its customer rates, its service charges, its customer service practices, its general business practices and its general tariff provisions will also be reviewed during the Commission Staff's review of the rate increase requests, and may thus be the subject of Staff recommendations at the conclusion of the rate increase process.
