## ORDER DIRECTING FILING

On March 27, 2006, Lincoln County Utilities Co. (Lincoln Utilities) filed an application with the Missouri Public Service Commission for authority to sell its sewer/treatment facility to the Public Water Supply District No. 1 of Lincoln County, Missouri (Water District).

Commission Rule 4 CSR 240-2.060(1) states, in part:

All applications shall comply with the requirements of these rules and shall include the following information: (A)...the street and mailing address of the principal office or place of business of each applicant and each applicant's electronic mail address, fax number and telephone number, if any...;

Lincoln Utilities' application did not comply with that part of Commission Rule 4 CSR 240-2.060(1) cited above in that it did not include the its electronic mail address, fax number and telephone number, if any.

Commission Rule 4 CSR 240-2.080(18) states that "the party filing a pleading or brief shall serve each other party a copy of the pleading or brief and cover letter." Commission Rule 4 CSR 240-2.080(19) states that "[e]very pleading or brief shall include a certificate of service." Lincoln Utilities' application did not comply with this rule in that it did

not include a certificate of service indicating that the application was served on the Office of the Public Counsel<sup>1</sup> or the General Counsel of the Commission.

The format of all pleadings filed with the Commission must comply with Commission Rule 4 CSR 240-2.080. Lincoln Utilities' application was not in compliance with Commission Rule 4 CSR 240.2.080.

Lincoln Utilities will be required to file a supplemental pleading curing these defects and to format all future pleadings in compliance with Commission Rule 4 CSR 240-2.080.

## IT IS ORDERED THAT:

- 1. Lincoln County Utilities Co., shall file, no later than April 11, 2006, a supplemental pleading which shall include a statement indicating its electronic mail address, fax number and telephone number, if any.
- 2. Lincoln County Utilities Co., shall file, no later than April 11, 2006, a certificate of service indicating that its application has been served on the Office of the Public Counsel and on the General Counsel of the Commission.
- Lincoln County Utilities Co., shall format all future pleadings filed with the Commission according to Commission Rule 4 CSR 240-2.080.
