**THE COMMISSION ORDERS THAT:**

1. The Commission shall hold a local public hearing at **12:00 p.m. on Tuesday, May 9, 2017**, in Warrensburg, Missouri, at the University of Central Missouri at:

An informal question-and-answer session will begin at 12:00 p.m., with the taking of testimony from residents at the conclusion of the information session. Elm Hills Utility Operating shall have a representative at the question-and-answer session to answer questions from the public.

2. The Commission shall hold a local public hearing at **6:00 p.m. on Tuesday, May 9, 2017**, in Sedalia, Missouri at:

Sedalia, MO 65301

An informal question-and-answer session will begin at 6:00 p.m., with the taking of testimony from residents at the conclusion of the information session.

3. Elm Hills Utility Operating shall have a representative at the question-and-answer sessions to answer questions from the public.

4. No later than April 30, 2017, Joint Applicants shall provide written notice of the local public hearings to customers impacted by the Application.

5. The Commission's Public Policy and Outreach Department shall make notice of this order available to members of the General Assembly representing Johnson and Pettis Counties, Missouri, and to the news media serving the residents of those counties.

Individuals wishing to make written comments or secure additional information may contact the Office of the Public Counsel, Post Office Box 2230, Jefferson City, Missouri 65102 or by using the Commission's Electronic Filing and Information System (EFIS) at [www.psc.mo.gov](http://www.psc.mo.gov). 7. The local public hearings will be held in facilities that meet the accessibility requirements of the American with Disabilities Act.
