ORDER DIRECTING FILING OF STAFF RECOMMENDATION

On November 16, 2017, the Missouri Public Service Commission ("Commission") issued an *Order Directing Notice and Order Directing Filing*, which required the Commission's Staff to file a pleading stating when it anticipates submitting its recommendation in this matter. On December 6, 2017, Staff filed a pleading stating that it intends to submit its recommendation no later than January 10, 2018. Ten days have elapsed, and no party has objected to the proposed filing date.¹ The Commission will order its Staff to file a recommendation responding to the application.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a Staff Recommendation no later than January 10, 2018.

¹ Commission rule 4 CSR 240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.

2. This order shall become effective when issued.
