

COMES NOW the Southern Missouri Gas Company, L.P. ("SMGC") and respectfully states as follows:


1. On January 9, 2003, SMGC filed the Direct Testimony of Scott F. Klemm in this proceeding. Schedule No. 2 of his Direct Testimony contained calculations related to the interest of the Company's Deferred Carrying Cost Balance ("DCCB").

2. SMGC has discovered that Schedule No. 2 was not prepared in a manner consistent with the methods used by other local distribution companies to calculate interest on the DCCB, pursuant to the standard provisions of the PGA/ACA tariffs.

3. SMGC requests permission to file the Supplemental Direct Testimony of Scott F. Klemm which replaces the original Schedule No. 2 and explains the reasons for the revisions.


