1. On January 30, 2014, Summit Investment, LLC (Summit) filed formal complaints against Osage Water Company (Osage) with the Missouri Public Service Commission (Commission) alleging that Osage has failed and refused on repeated occasions to extend water and sewer service to additional lots within its certificated service area, thereby preventing Summit from developing and selling those lots.
