The undersigned acknowledges full settlement and satisfaction of any and all claims, past, present or future, of whatsoever kind or character, against the persons, firms and corporations herein released.

The undersigned understands that liability is wholly denied by the parties herein released, who have made no representations, agreements or promises to do or omit to do any act or thing not herein set forth and that the waiver herein made to and received by the undersigned is in full settlement and satisfaction of all claims, demands, causes of action and rights of action for damages of whatsoever kind or nature, whether known or unknown, including any future developments thereof, whether now anticipated or not, at this or any future time in any way growing out of or connected with said collection and that the consideration expressed herein is the sole and only consideration therefor.

In executing this Release, the undersigned understands that the terms hereof are contractual and not a mere recital and agrees that she is not relying upon any statement or representation made by the parties hereby released or any of their agents concerning the nature, extent or duration of the damages, or concerning any other thing or matter, but relies solely upon her judgment and the advice of her attorney. The undersigned further agrees not to disclose to any person any information regarding this release or the terms thereof to any individual other than legal counsel.

It is further understood and agreed that this Release shall be binding upon and inure to the benefit of the heirs, executors, administrators, legatees, assigns and the directors, officers, agents, representatives, servants, employees and their respective heirs, personal representatives and assigns, as well as the successors and assigns, if any, of the undersigned and/or parties hereby released.

It is further understood and agreed that the administrative complaint entitled JOCELYN Lewis vs. Raytown Water Company; File No. WC-2023-0166, filed before the Public Service Commission of the State of Missouri, shall be dismissed with prejudice, each party to bear their own costs.
