On July 1, Crossroads Network, LLC (“the Company”) pursuant to Section 392.550, RSMo, filed an application for certificate of service authority to provide Basic Local Telecommunications Service in the following exchanges:

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. 4. This file may be closed on July 17, 2021.
