ORDER CANCELING ETC DESIGNATION

Issue Date: September 4, 2018

Effective Date: September 14, 2018

On August 2, 2018, the Commission's Staff filed a *Motion to Cancel Eligible Telecommunications Provider Status of Blue Jay Wireless, LLC* ("Blue Jay").¹ The Motion explained that Blue Jay had not filed its required 2017 Annual Lifeline Eligible Telecommunications Carrier Certification form (Form 555), which had been due no later than January 2, 2018, until February 21, 2018. The Motion further stated that Blue Jay had not yet filed its ETC Annual Filing (Form 481), which had been due no later than July 1, 2018. The Motion also stated that although Blue Jay had updated its contact information in EFIS in March 2018, all Staff attempts to reach Blue Jay had failed, Blue Jay's website was inoperable, Staff could locate no additional contact information, and an online notification from another company had stated that Blue Jay customers would become that company's customers as of July 6, 2017. In its Motion of August 2, 2018, Staff alleged that the Commission should cancel Blue Jay's ETC status because of its failure to meet the filing requirements of 4 CSR 240-31.120(2) and the ETC requirements of 4 CSR 240-31.130(2).

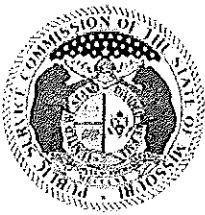
¹ On May 15, 2013, the Commission had granted the application of Blue Jay for designation as an ETC in order to receive federal universal service support for Lifeline services.

On August 3, 2018, the Commission issued its Notice of Contested Case and Order Directing Filing ("Notice"), directing that Blue Jay be served by certified mail, postage prepaid, to Blue Jay Wireless, LLC, 5010 Addison Circle Addison TX 75001; and directing that Blue Jay file an answer no later than September 3, 2018. On August 24, 2018, the undelivered Notice was filed in EFIS. Blue Jay has not filed an answer.

The Commission will grant Staff's motion.

THE COMMISSION ORDERS THAT:

1. Blue Jay Wireless, LLC's designation as an Eligible Telecommunications carrier in order to qualify and receive federal universal service support for Lifeline and Disabled programs is cancelled.
2. This Order shall be effective on September 14, 2018.




