## **STAFF'S MOTION TO EXTEND FILING DEADLINE AND STATUS REPORT**

COMES NOW the Staff of the Missouri Public Service Commission, by and through Counsel, and states:

1. On May 18, 2009, Entelegent Solutions, Inc., ("Entelegent") filed its Application for Certificates of Service Authority to provide basic local exchange, nonswitched local exchange, and interexchange telecommunications services in Missouri, and to classify said services and the company as Competitive.

2. The Commission directed the Staff to file a Recommendation as to the Application no later than June 30, 2009.

3. On June 30, 2009, Staff filed its Motion to Extend Filing Deadline, as at that time, Entelegent had not filed all information necessary to complete its Application.

4. On June 30, 2009, the Commission directed the Staff to file a Recommendation as to the Application no later than July 30, 2009.

5. On July 30, the Commission ordered that "[n]o later than August 14, 2009, Staff shall file either its recommendation concerning Entelegent Solutions, Inc.'s application or a status report advising when it believes it will be able to file its recommendation."

6. To date, Entelegent has not filed all information necessary to complete its Application. In particular, certain financial information has not been provided.

7. Absent this financial information, Staff is unable to recommend the granting of the Certificates and Designations requested in Entelegent's Application.

8. In its attached Status Report [Appendix A] Staff states that the Financial Analysis Department continues to work with the company on this matter.

9. The Staff respectfully requests the extension of time to file its recommendation until August 28, 2009, to allow time for Entelegent to file the necessary information, and Staff to evaluate said information.

10. The Staff does not believe that any party will be harmed by the granting of its request for an extension of time to file its recommendation. The Staff does not make its request so as to unduly delay these proceedings.

WHEREFORE the Staff requests that the Commission accept Staff's Status Report, and grant it an extension of time to August 28, 2009 for the filing of the Staff's recommendation in the instant case.
