NOTICE OF DEFICIENCY

On July 21, 2022, BIF IV Intrepid OpCo LLC filed an application seeking a certificate of service authority to provide Non-Switched Local Telecommunications Service and Interexchange Telecommunications Service in the following exchanges:

Statewide

Commission Rule 20 CSR 4240-4.017 requires that an applicant file a notice at least 60 days before filing their application. That requirement can be waived by the Commission. A request for waiver can be accomplished by following instructions on the Commission's website that require that applications for registration to provide Interconnected Voice over Internet Protocol service contain a statement that:

by signing this form, I hereby certify that neither I, nor any other members of this filing party, has had communications with a Commissioner, Commissioner Advisor, Regulatory Law Judge, member of the General Counsel or any member of their support team in the sixty (60) days prior to the filing date of this application regarding any substantive issue included in this filing. If any communication of this sort has occurred in the previous sixty (60) day period, I further certify this application was held until sixty (60) days have passed from the date of the subject communication, or we have requested a waiver for good cause as allowed by Commission Rule 20 CSR 4240-4.017(1)(D).

This language is incorporated in the application form and affidavit included on the Commission's website as paragraph 9 of the affidavit.

The Commission will not take action on BIF IV Intrepid OpCo LLC's Application seeking a certificate of service authority to provide Non-Switched Local Telecommunications Service and Interexchange Telecommunications Service until these deficiencies are corrected.
