AMENDED CERTIFICATION TO PROVIDE TELECOMMUNICATION SERVICES

On September 30, 2022, Everfast Fiber Networks LLC (“the Company”) pursuant to Section 392.550, RSMo, filed an application seeking a certificate of service authority to provide Basic Local Telecommunications Service and Interexchange Telecommunications Service in the following exchanges:

Statewide

On October 6, 2022 the Commission issued a Certification to Provide Telecommunication Services that granted Everfast Fiber Networks LLC certification to provide Non-Switched Local Telecommunications Service and Interexchange Telecommunications Service. The Commission neglected to include Basic Local Telecommunications Service.

The Commission has reviewed the application filed by the Company, as well as the supplement, and finds that the application and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the Office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the

Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

1. Everfast Fiber Networks LLC is granted certification to provide Basic Local Telecommunications Service, in addition to the previously granted certification to provide Non-Switched Local Telecommunications Service and Interexchange Telecommunications Service, in the exchanges set forth in the affidavit attached to the application and restated above.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on February 18, 2023.
4. This file may be closed on February 19, 2023.
