**LACLEDE GAS COMPANY'S
STATUS REPORT**

COMES NOW Laclede Gas Company (“Laclede” or “Company”) and submits this Status Report, stating as follows:

1. On August 31, 2007, Laclede filed an application (the “Application”) to abandon L.P. Gas Service to customers in the Meadowview Acres Mobile Home Park in Jefferson County, Missouri (the “Park”). On November 20, 2007, the Commission approved the Application, subject to certain conditions. The Commission also required Laclede to file any necessary tariff revisions or in lieu thereof, file a status report.

2. Laclede states that no tariff revision is necessary. The portion of Laclede’s tariff applicable to General L.P. Gas Service is still in effect and Laclede is currently serving other customers pursuant to those tariff provisions. The effect of the order in this case was merely to permit Laclede to sell its assets at the Park to another service provider and abandon General L.P. Gas Service to customers at that specific location, because it was no longer economically feasible for the Company to continue to serve those customers.

3. The asset sale has been completed and AmeriGas is currently providing propane service to customers at the Park. In summary, no further action is necessary in this case.

4. The Commission's November 20, 2007 Order set January 18, 2008 as the date for the filing of this status report. Laclede was under the mistaken belief that because no tariff filing was necessary this matter had been resolved. Laclede apologizes to the Commission for the delay in filing this status report and requests that the Commission accept this late filing.

WHEREFORE, Laclede Gas Company respectfully requests that the Commission accept this late-filed status report and close this case.
