STATUS REPORT

COMES NOW Southwestern Bell Telephone Company (SWBT), and pursuant to the Missouri Public Service Commission's (Commission's) July 20, 2000, Order Approving Transfer of Assets and September 7, 2000, Order Directing Filing, provides the following Status Report to the Commission:

1. On July 20, 2000, the Commission approved SWBT's application to transfer certain legal department support assets to SBC Management Services, Inc. and authorized SWBT "to take any and all actions necessary to effect the transfer of assets to SBC Management Services, Inc." (Order at p. 8). The Commission also directed SWBT to "report to the Commission within ten business days of the completion of the approved transfer of assets that such has been accomplished." (Id.)
2. SWBT accomplished the Commission-approved transfer of support assets to SBC Management Services, Inc. on August 2, 2000.
3. Due to an inadvertent oversight SWBT did not report the completion of the transfer of assets to SBC Management Services, Inc. within ten business days of its occurrence.
4. On September 7, 2000, the Commission issued its Order Directing Filing in this case, in which it ordered SWBT to provide a report on the status of this case by September 22, 2000. SWBT respectfully reports that as described above, on August 2, 2000 SWBT completed

the transfer of assets to SBC Management Services, Inc. authorized by the Commission on July 20, 2000.


