JOINT STATUS REPORT

COME NOW MCImetro Access Transmission Services, LLC, Brooks Fiber Communications of Missouri, Inc. and Intermedia Communications, Inc. (collectively hereinafter referred to as "MCI"), on behalf of themselves and on behalf of CenturyTel of Missouri, LLC ("CenturyTel"), and the Staff of the Missouri Public Service Commission ("Staff"), and pursuant to Commission Order for the parties' Joint Status Report state:

1. On March 9, 2005 the Commission issued its Order Granting Joint Motion to Suspend Procedural Schedule and Canceling Hearing. Therein, the Commission directed the parties to file a Joint Status Report regarding settlement negotiations on April 8, 2005.
2. MCI and CenturyTel have signed documents to amend their interconnection agreements and are in the process of preparing the necessary pleadings to submit those amendments to the Commission. Upon approval of the amendments, the matters at issue herein will be resolved and MCI will be able to dismiss its Complaint and all parties will consent thereto.
3. Accordingly, the Commission should continue to suspend these proceedings, pending completion of the settlement process.

WHEREFORE, on behalf of the parties, MCI requests that the Commission accept this Joint Status Report and continue to suspend these proceedings.
