STIPULATION AND AGREEMENT

Comes now Time Warner Cable Information Services (Missouri), LLC (“TWCIS”) d/b/a Time Warner Cable, by its undersigned counsel, and hereby submits the following Stipulation and Agreement on behalf of the undersigned parties.

1. On January 30, 2004 the parties to this proceeding met at a prehearing conference convened by the Commission. At the prehearing conference, TWCIS agreed to amend its Application, and the parties contesting the requested grant of authority agreed to withdraw their opposition and requests for intervention upon completion of such amendment. Those parties supporting or not opposing the original requested grant of authority agreed to support or not oppose the amended requested grant of authority.

2. TWCIS is filing simultaneously herewith a Motion to Amend its Application, by interlineation, to delete references to the phrase “provide local and interexchange voice service” and insert in its place the phrase “provide basic local, local and interexchange voice service.”

3. The foregoing amendments will make the request for authority consistent with this Stipulation.

4. The amendments referenced in paragraph 2 above are the only amendments to the Application. All other content and allegations of the Application, including the Appendices, remain unchanged by these amendments.

5. Commission Rule 4 CSR 240-2.115 authorizes the parties to file a stipulation and agreement as a proposed resolution of all or any part of a contested case.

WHEREFORE, all of the undersigned parties recommend the Commission accept this Stipulation and Agreement and TWCIS' Amendment to its Application.
