Enclosed for filing please find an original and fourteen copies of the Company's Application for approval of an agreement with the Meramec Sewer Company in Jefferson County, Missouri ("MSC"), providing for water service termination for unpaid sewer bills. Although this Company has relatively few customers within the service area of the Meramec Sewer Company, we have been requested to enter into an agreement with this sewer company on the same terms and conditions under which the Company has already contracted with MSD with the previous approval of this Commission. Attached as exhibits to the Application are the executed Agreement between the Company and MSC, and the associated tariff.
