Missouri Gas Utility, Inc. is required to file tariff sheets to show the rates and conditions under which natural gas service will be offered in its expansion of its Southern Service Area, which serves the towns of Green Ridge, Cole Camp, Lincoln and Warsaw, as well as the adjacent territory as approved in Case No. GA-2010-0012.

In reviewing the MGU tariff, the expansion of the southern service area required new sheets or substantive changes. In addition to these substantive changes, the information in the header on several Tariff Sheets listed each community, town or city which became burdensome as MGU expanded its certificated territory. The decision was made to define a Northern Service Area which includes certificated areas in the following counties: Harrison, Daviess and Caldwell and also the Southern Service Area which includes Benton, Camden, Miller, Morgan and Pettis County. The definition of each service area is stated on Tariff Sheet No. 1.
