Missouri Gas Utility, Inc. is required to file tariff sheets to show the rates and conditions under which natural gas service will be offered in its new Southern System, which serves the towns of Green Ridge, Cole Camp, Lincoln and Warsaw, as well as the adjacent territory as approved in Docket No. GA-2009-0264.

In reviewing the MGU tariff, the addition of the southern system required new sheets or substantive changes to the following sheets:

In addition to these substantive changes, the information in the header on each Tariff Sheet was specific to MGU's original system, which serves the towns of Gallatin, Hamilton and Coffey. In 2007, MGU also began service to three additional towns in the Northern Division: Ridgeway, Pattonsburg and Jamesport. The Tariff Sheets showing the maps and legal descriptions filed at the time those additional service areas were approved had the information in the header changed to reflect that they applied to all MGU certificated territory in the counties served by the Northern Division: Harrison, Daviess and Caldwell. The remaining tariff sheets that apply to the Northern Division did not have the information in the header updated. For those sheets that specifically apply to the Northern Division, this change has been made in this filing.

The bulk of the MGU tariff is the PGA and Rules sections. For these sections, except for the actual PGA Rate Sheets, the information in the header needs to reflect the fact that these sections apply to all territory certificated and served by MGU. This change has also been made in this filing.

Only Tariff Sheets 9, 12 and 53 had no changes. Sheets 12 and 53 are blank pages and the header information will be corrected when and if they are ever used. Sheet 9 refers to the rate changes from the original Gallatin and Hamilton municipal systems that became the MGU North Division, and the header should be left as originally filed since this only affected the three original towns. For clarity and continuity, these sheets have been left in the attached tariff document, which then constitutes the entirety of the MGU tariff as proposed following the approval of the CCN for the Southern Division.
